# The Rev. Dr. Anna Pinckney Straight Pastor and Head of Staff

When I look back on the last twelve months, I am filled with gratitude. In the past twelve months we have had to shift everything- our patterns, traditions, and priorities. To shift focus away from our go-go-go natures and stay home in order to protect those that we love, those that cannot stay home and those that have continued to show up on those front lines to take care of us.

The Wisconsin Council of Churches recently published new guidelines on how and when it will be safe and wise for churches to gather in-person again. In their introduction they stated some theological and ethical goals:

- Prioritize protecting the life and health of your neighbor
- Let yourself continue to be provoked into holy experiments
- Follow the call to love and good deeds urgently and care-fully
- Prioritizing accessibility honors the diversity and one-ness of Christ's church
- Take seriously the church's role as community leader
- Believe in the resilience of the church

I've been thinking and praying a good bit about that final statement, "believe in the resilience of the church." I believe we can trust that resilience and our own ability to embody and share the gospel. Because, as the poem on the next page reminded us in December (and still reminds us today), "we are the manger."

Finally, I know that there are things that are being missed (have been missed) during our time apart. If you have a need, if would like to talk or pray, please don't assume that I will hear about what's going on. Please get in touch (by phone or by email) and we will find a time to get together. I look forward to connecting with you. I am grateful to be your pastor. It is an honor in all times, but it has been a particular privilege in these times.

That's why I miss you most. A sanctuary can store a lot of hay –

but you are the manger.

Under the leadership of the Property Committee I am happy to report that the physical maintenance, security, safety, and continual operation of the church continues to improve.

The first quarter of 2020 was quite busy here at Old Stone. Monday was Moms Café, Tuesday and Thursday we had the STAIR program, Wednesday was LOGO'S. We had outside groups using the facility regularly. Then COVID put a halt to all activities.

This inactivity gave me the opportunity to perform additional tasks. Many of the interior doors were painted. Baseboards in Fellowship Hall, hallway and the restrooms were also painted. Many of the vinyl tile floors have been thoroughly cleaned and waxed. New tables and chairs were placed in Fellowship Hall and the Activity Room. The Choir Room and Sanctuary (choir) have new upholstered chairs. The school rooms have been reset to accommodate the Wednesday Enrichment "virtual learning" for students. Ethernet and Wi-Fi have been enhanced to support additional internet activity. Ring doorbells and cameras have been installed on the property. The Sanctuary has been upgraded with ethernet, cameras and sound system. Annual inspections and repairs were performed on the elevator, lift chair, fire extinguishers, fire sprinkler system and the fire alarm. The Lewisburg/Fairlea Food Locker is busier than ever on the third Saturday each month. A new tradition of placing a Christmas tree out front began this December 2020.

Scheduled for the spring of 2021 the Education Building will receive a new shingle roof. Hopefully 2021 brings back to the way things were. I look forward to seeing you soon.

#### Clerk of Session

2020 – what a year!! We all know that Old Stone Presbyterian Church, along with everyone else in the country, had no idea what was in store for us! In March, the Session and leadership met to make decisions, for what they thought would be a few weeks, on how to proceed when the Covid-19 virus hit the country.

The Session held eleven (11) Stated Session meetings, two (2) Called meetings, and five (5) "Extra" Session meetings. The church also held the Annual meeting for 2019. Some highlights of the meetings included:

- Stated Meetings The Session meets the first Wednesday of each month to conduct the regular business of the church, along with hearing reports from the Session committees. At the regular Stated meeting in May, it was decided that, with how things were changing day to day, hour to hour, it would be a good idea for them to meet twice a month.
- Called Meetings In January, the Session called a meeting for the purpose of examining the newly elected Elders, Class of 2022, prior to the Ordination and Installation Service, and in March another meeting was called for the purpose of making plans as to how the church would move forward during the Covid-19 virus.
- Congregational Meeting The Session called a Congregational meeting in November for the purpose of electing Ruling Elders, Class of 2023; Trustees, Class of 2023; and the Nominating Committee for 2021,

During 2020, Old Stone Presbyterian Church mourned the death of four (4) members.

Starting in April, the Session moved from meeting in-person to meeting via Zoom, and they continue to meet virtually. Also, in April, the Session approved the application for a PPP loan through the Small Business Administration.

Even thought things have been happening in very different ways, in July, the Session welcomed four (4) new members into the congregation of Old Stone Presbyterian Church. These individuals met with the Session at their regular Stated meeting, via Zoom. The church was also blessed to welcome three infants into the life of OSPC.

The Manual of Operations for OSPC was updated/revised and was approved by Session; adding a Virtual Meeting Policy to the manual.

As 2020 has ended and 2021 has begun, the Session would like to thank the Ruling Elders of the Class of 2020 for their service and dedication to the OSPC. Members of the Class of 2019 are: LeeAnn Gillilan, Larry Jones, Dick Marshall, Joan Montgomery and Rodney Weikle.

#### **Personnel Committee**

In 2020, the personnel committee's primary goal was to keep the minister and staff safe throughout the pandemic and during pressing congregational concerns.

Performance: While adhering to the COVID 19 Guidelines has not been easy, the staff have devoted more work hours, met tighter deadlines, adhered to external standards, communicated more, thought innovatively, learned newly evolving technology with little or no ramp up time, and have been implemented new ways of accomplishing work and living the mission of the church. They have exhibited extraordinary efforts during extraordinary times; and we are grateful for them. Also, the committee appreciates Dena Williams for locating, editing, and formatting hymns for on-line services.

In July, the committee reviewed each role and whether current operations would result in a lasting change in the number of hours hired. Personnel concluded:

- the right people are in the right jobs;
- the need to adapt to and develop new skills is not limited to the pandemic but will be ongoing as church traditions evolve; and
- given the current information, we do not anticipate downsizing staff.

Pastor Straight discussed job agreements what has gone well, what could have gone better, goals and desired leadership during annual performance discussions with the staff.

**Hires:** The committee hired part-time (est. two hours per week) to provide technical support for live streaming.

Benefits: Personnel recommended, and Session agreed to offer temporary disability benefits through the Board of Pensions for those eligible which includes two full-time employees. The Board of Pensions requires the coverage be provided for Ministers so Pastor Straight is also included in the group. The coverage is inexpensive, protects the employee and saves church money by covering extended illness for which the church has covered the cost in the past. Beginning January 2021, the temporary disability provides 60% of income from the 15th day of illness up to the 90th day when the employee may be eligible for long-term disability.

#### **Committees**

Community Action (Lou Ella Lewis, Mary Scarborough, Linda Hayes, and JoAnn Pearis) This committee is responsible for promoting the Presbyterian Women's Thank Offering in November. They did an outstanding job this year at remembering the shut-ins of Old Stone with cards and bud vases at Christmas.

**Spiritual Enrichment** (Darlene Hicks and Linda Hayes) In addition to providing a devotional message at our meetings, this committee supported a card ministry for our church members that are sick, lonely, and have lost loved ones. The card ministry was recently assigned to various members of the Circles.

A Facebook group for the Women of Old Stone has been set up by Becky Mahlburg and is available on the church's Facebook page. An email was sent to all members of the Circles inviting them to participate.

Together in Service (Pam Lewis, Jewel Dolan, and Becky Kelso) This committee selects a local mission to support for the year. The Drug Free Mother and Baby Program has been introduced to the women's council as our next mission. This program supports mothers using drugs while pregnant and mentors them during their delivery/hospital stay.

**Women's Retreat** (Amy Brown, Susan Graham, and Amy Kesterson) No retreat was held this year.

#### **Projects**

Americana (Lynn Weikle and Brenda Jones) Our thrift store accepts clothing and household donations from the community and sorts/resells them to the community with 100% of the proceeds going to local organizations that assist those in need. We were closed in March due to COVID-19 but conducted an outside yard sale on the front porch of the church at the end of September. We reopened the store in September with shortened COVID-19 hours and remained open until Christmas week. We have contracted to have a new door installed to the thrift store, which should happen early in 2021.

Care and Gwen's Meals (Betty Dempsey and Arlen Myers) This program provides bereavement meals for funerals or memorial services and provides meals for The Shepherd Center to be delivered through their Faith in Action Program.

Flowers (Betty Dempsey and Pam Lewis) Provides and cares for flowers in the sanctuary.

McCormick House (Amy Brown and Lynn Weikle) Two fun winter activities and devotional time were held with the young women at Davis Stuart House before COVID-19 hit the area in March. In January we hosted the girls at O'Shea's All About Beauty, where each young lady received a new hair style and had their makeup and nails done. For February, Elizabeth McDowell, founder of Charlie's Market, hosted a jewelry making party and devotion time at Old Stone. Despite our need to stay safe and not meet in person, we have continued to support the McCormick House. Over the summer, we provided flowers and mulch for their flower garden. We have also brought art supplies and treats bi-monthly. We also provided Christmas gifts for each of these ladies.

**Scholarships** (Betty Dempsey) Providing local scholarships to the New River Technical College and Old Stone Preschool. The College has not yet provided information on a new recipient for next year.

**STAIR Tutoring** (Debbie Taylor) This project provides a tutor with second grade students that are struggling with reading during the school year. We were able to tutor 8 students this year with 15 tutors, 3 substitutes, 1 paw dog team, and 18 snack providers. All students increased their reading skills, with several now on a 3<sup>rd</sup> grade level.

#### The Board of Trustees

Trustees for year 2020 included:

The function of the trustees is to manage permanent trust funds according to their terms, and properties for the furtherance of the purposes of the congregation, which included the following in 2020:

- 1) Authorized check totaling \$7400.18 (tables, internet and wi-fi equipment). The McClung Evans Trust provided the funds.
- 2) Reviewed fee policy and investment performance returns for invested trust assets.

We value the leadership and input that our minister, Anna Straight, provided us in 2020, and look forward to 2021.

December Offerings were under budget for the month and for the full year. For the year, pledged giving was under budget \$6,150 and other offerings were \$3,741 below budget. Other Income continued to be under budget since it included the weekday school tuition.

Compensation was \$26,861 below budget due to the closing of the weekday school. Compensation for remaining staff was on budget. Printing costs were over budget \$1,071 offsetting the savings in Advertising. Postage expense was \$1,981 over budget due to increased mailings during the pandemic. Occupancy was \$5,057 below due to lower utilities and less in maintenance costs. Fees for services were under budget \$7,986 because of lower expenses for accounting services and musicians. Travel and Conference expense was \$8,197 below budget due to the cancellation of the youth mission trip this year. Supplies expense were \$6,066 lower than planned due to closing of the weekday school and few in person activities in the church building. Information & technology costs were \$5,116 higher than planned due to Radio Greenbrier expense and internet equipment upgrades. Church social expenses were \$3,501 less than budget since we were not able to have church gatherings.

The operating deficit was \$3,386 less than planned for the year.

The Small Business Administration (SBA) has forgiven \$ 42,521.86 of our Payroll Protection Plan Loan (PPP) leaving a balance of \$13,975.64. We have repaid \$3,975.64 and are working on the forgiveness of the remaining \$10,000 balance. We have the funds to repay that amount and will do so if forgiveness is not approved by the SBA.
