Christian Education

The Christian Education Committee aims to offer opportunities to learn about the world God created, our faith in it, and how to find purpose and meaning through God's will for our lives.

In the early part of 2021, our Wednesday Enrichment program continued to provide a fun and focused place for our teens to work on virtual assignments, build community amongst themselves, and participate in devotions and Bible study.

As public schools returned to more in-seat learning, those classrooms were reinvented for our STAIR and Logos programs, providing a designated space for our elementary aged children. Debbie Taylor worked overtime to put the wheels back on the second-grade literacy tutoring program, providing a much-needed service for at-risk students who experienced learning-loss during virtual and remote education days.

For the first time, the Christian Education Committee sponsored The Stations of the Cross on Good Friday, providing time for devotions and reflection. Several members of the community at-large also stopped by to participate.

PYC managed to participate in a mission trip with Appalachia Service Project, serving in WV for the first time as part of a high school mission trip. Our teens roofed a house and installed insulation and drywall in three homes located in West Charleston. The goal is to make homes warmer, safer, and drier.

Bluestone Church Camp looked a little different in 2021, but the children and youth who took advantage of the program had an amazing time and certainly learned about God's amazing love while exploring God's amazing creation!

Adult Sunday School classes, as well as PYC, continued to meet...sometimes virtually and gradually in-person...and sometimes in a hybrid format!

With some trial and error – and practice – our children and teens produced virtual worship services when we were unable to worship in-person. At Christmas there was even a cow dressed up as a sheep! We are so very thankful for their creativity and leadership!

Thank you to the many enthusiastic and creative volunteers who have stepped up to make the committee and its endeavors special and relevant. We just can't wait to see what God has in store for us in 2022!

To the congregation of the Old Stone Presbyterian Church,

I would first like to extend my thanks for officially welcoming me into your church family. This is the third year that I have been a part of the Old Stone services, but this year has brought many new changes, challenges, and triumphs for our Music Department.

We began the year with our hybrid, virtual services. Bridgett Edwards and I alternated weeks playing organ and working with members of the choir, Dena Williams, Brahm Kesterson, and Pastor Anna to arrange our services. We had some Sunday mornings with a live organist and one vocalist, and many others with recorded musical selections. Choir members were so gracious to be flexible, while singing in a variety of arrangements, as soloists, duets, quartets, and extended quartets. I am very thankful for each person's willingness to provide their voices to lead our worship.

As the year progressed, things began to change within our Music Department. Dr. McClinton's health began to decline, and Bridgett Edwards received a diagnosis of Pancreatic Cancer and began treatments. As two pillars of the Music Department were forced to focus on their health, I leaned heavily on our choir members for support. I accepted an interim role of managing the weekly music along with Pastor Anna, Renee and Amy Ahern, and Dena Williams. Dena compiled a large catalog of recorded videos which we were able to use in case of emergency. I recorded anthems, hymns, piano accompaniments for the choir, and videos of our choir singing, which were played through our speakers during worship services.

As spring came, the heavenly chorus gained new members. In Calvin's final weeks, we were able to take our extended community choir to sing a concert outside of his window at the Peyton Hospice House. We were able to fellowship with him and sing some of our favorite hymns, anthems, and share some of our last moments with him. We then celebrated his life with a moving, music-filled funeral service, in which we all felt his presence from heaven above.

Unfortunately, very soon after, the choir had another horrible loss, with the sudden passing of Ron Snyder. Ron was a very dedicated member of the choir and church for many, many years. Ron blessed us all and truly sang from his heart to glorify the Lord. The choir sang a wonderful arrangement of Country Roads as a send-off at Ron's

funeral, arranged by Gary Williams. We miss both Ron and Calvin dearly, but know they are rejoicing with a much greater chorus where we will meet again one day.

Although we had a few dark months, we were able to have the light of summer bring some brightness to our choir and congregation. Summer came, and the church was able to have a special gathering at Merry Hill following the morning worship service. The choir was able to sing a few songs, the Men of Old Stone, Etc. (MOOSE) performed on the porch, and the congregation joined in singing Country Roads to end the afternoon.

As the seasons changed, our focus shifted to returning to normal worship services. We had two wonderful accompanists join our department. Our very own, Lawson Hamilton, began playing the organ and piano to provide Preludes, Offertories, and Postludes for worship services. Andrea Edge joined us as a part-time organist/accompanist and has also shared her vocal talents with our congregation as well. The choir was able to meet regularly on Monday evenings and prepare anthems for our weekly services. We concluded the year with our traditional Advent services and a rousing Music Sunday in December where we were joined with the return of the Bell Choir.

As we welcome a new year, we embrace change, but honor the legacy of those who have created such a strong musical worship experience for our congregation. Many plans for the upcoming year have been laid, and I am excited to continue to make a joyful noise to the Lord and worship with you all as we move forward into this new chapter at Old Stone Presbyterian Church.

Under the leadership of the Property Committee I am happy to once again report that the physical maintenance, security, safety, and continual operation of the church continues to improve.

Annual inspections of the elevator, lift chair, fire extinguishers, fire sprinkler system, and the fire alarm have been completed.

April 2021, with funding from a Peyton grant, architectural 50 year shingles were installed on the Education Building. Other 2021 projects included a new door on the Thrift Shop, a new ice maker in Fellowship Hall kitchen, hinges installed on the Fellowship Hall entrance doors, curb welding repair, outdoor wall light fixtures facing Foster Street and Fellowship Hall playground area installed, Foster Street lamp post light repaired and changed to LED, four outdoor lantern light fixtures converted to dusk/dawn and LED bulbs, LED bulbs installed in the chandeliers of the Education Building main hallway, LED bulbs installed in the chandeliers of the Sanctuary.

Projects for 2022 include repairs to the Sanctuary patio and grout repair above Sanctuary entrance doors (Thank you Trip Hamilton for spearheading this project!). Occasionally rain water seeps into the Food Locker pantry and that will be addressed in the spring.

I would like to take this opportunity to thank Amy and Stuart Brown's boys Nixon, Jeb and Asa, Carroll Crane, Mike Leland and Chuck Lewis for keeping the grass mowed after my shoulder surgery in May. Others I have called upon include Wilson Bland and Tim Holbrook. Electrician Roger Dilley and Plumber David Alderman are just a call away. Clifford Gillilan always is helpful with questions about the building. Special thanks to Carroll Crane, Trip and Lawson Hamilton for helping with snow removal.

Nancy Smallenberger, Clerk of Session

2021 was another busy year for the Session of Old Stone Presbyterian Church. The Session met for twelve (12) Stated meetings; nine (9) Called meetings; one (1) Ordination and Installation Service; and two (2) Congregational meetings.

In January, Session was still meeting by Zoom and continued to do so until November when the meetings became hybrid.

In February, the Session and congregation held the Annual meeting – via Zoom. Items addressed were: returning to in-person worship, church finances and pastoral concerns within the congregation.

In March, the Session had a Called meeting at which time the Rev. Dr. Anna Pinckney Straight informed the Session that she had accepted a new call, beginning June 28, 2021. The next step for Session was to then meet with Rev. David Lee, who was assigned to serve as Moderator by the Committee on Ministry with the Presbytery, and Rev. Edward Thompson, General Presbyter of the Presbytery of West Virginia. The Session held several virtual meetings with Rev. Lee and Rev. Thompson, at which time many topics were discussed, including: establishing what "we" see as the priorities moving forward with the transition process, including: someone to begin the process of contacting individuals to fill the pulpit on Sundays; forming a Worship committee to take on the daily/weekly items in order to have Sunday morning worship services; someone/or a group to work on times and ways to hold conversations with the congregation to see where they see the church – what are the priorities for OSPC moving forward and what have we learned about ourselves in the last five years. Also discussed were: what type of leadership would best serve the church moving forward - Pulpit Supply, Stated Supply, Interim or Called Pastor; and gathering information for the M.I.F. (Ministry Information Form).

During a called meeting in April, the Session decided to search for an Interim Pastor and to form an I.P.N.C. (Interim Pastor Nominating Committee). This committee is elected by the Session. Three Elders volunteered to serve, including: Doug Bicksler, Tracy Morgan and Jim Coleman. Names of other church members were suggested, with Bicksler agreeing to contact them to see if they would be willing serve on the committee. At the May Stated meeting, the following were elected to serve on the I.P.N.C.: Doug Bicksler, Tracy Morgan, Jim Coleman, Sharon Rowe and Andy Kelso.

On Sunday, May 2, there was a Congregational Meeting at which time it was voted and approved to dissolve the pastoral relationship between Old Stone Presbyterian Church and the Rev. Dr. Anna Pinckney Straight.

The Session also held a number of Called meetings to make decisions in regards to Covid guidelines for in-person worship and when it was necessary to make the decision to cancel in-person services.

In September, the Session met for a Called meeting at which time they met with a candidate to serve as Interim Pastor. At this meeting, the Session voted to issue a call to the Rev. Jeff Binder to serve as our Interim Pastor and to request a meeting with the Presbytery's Committee on Ministry.

On Sunday, October 24, Rev. Binder was welcomed to the pulpit by the congregation, who was happy to be able to meet in-person once again.

The Session called a Congregational Meeting to be held on Sunday, December 19, at which time the Nominating committee presented a slate of officers and 2022 Nominating committee. To serve on the 2022 Nominating Committee are: Cam Huffman, Marcia Leitch and Michael Meadows. To serve as Elders, Class of 2024: Jim Rowe, Jennifer Runyon, Joan Montgomery and Sara Irons and to serve as Trustees, Class of 2024: Gordon Campbell and Herb Pearis. All of these individuals had agreed to serve and were unanimously elected to serve.

The Session is continuing to hold their monthly Stated meetings to conduct the regular business of the church, along with hearing reports from the Session committees.

During 2021, Old Stone Presbyterian Church mourned the death of five (5) members.

In May, we wished the Straight family farewell. Then, on May 30th, we returned to in-person worship! The Worship Committee had the pleasure of arranging and welcoming familiar friends, Becky Williams and John Arbuckle, to the pulpit several times. We were grateful for Doc's friends, Rev. Jerome Basham, Rev. John McCants, Jr., and Elder Pete Moore, who led a unique and moving service in his memory. We were blessed to have the leadership and loving care of Reverend Cam Harkness upon the Snyder family's unexpected loss.

Rev. Harkness organized and conducted a beautiful service honoring Mr. Snyder. Rev. Betsy Walker of St. Thomas Episcopal stepped in to lead the uplifting service in memory of Patsy Wingo. Rev. Harkness, again, graciously offered his assistance to the family of Art Mashburn after Mr. Mashburn's passing. Dr. Brennan Wood skillfully arranged, played, and or directed the music for those very special funerals. Jim Seeley prepared the sanctuary and receiving rooms beautifully. Several members of the congregation, as well, helped ensure that the services and families were cared for properly. Thank you!

Sunday, July 11th was Picnic Sunday! We had about 120 in attendance at church and a few more at the picnic! It was the most people in church since 2019! After a very long 14 months of the pandemic, The Picnic provided that needed reunion for our congregation. We are grateful to Bob Perkins, Cam Harkness, Trip Hamilton, and the late Ron Snyder for putting their hearts into creating that special opportunity for fellowship after worship.

Due to a spike in Covid infections following the State Fair, part of September and October worship services returned to virtual and radio only. It was hard to believe we were back in that spot again. Though the GMS Reunion was canceled, GMS alumni John Arbuckle and Bill Satterfield led us in worship by Livestream and radio featuring favorite GMS worship music and memories. If 2020 and 2021 have taught us anything, it is to be flexible and remain faithful! We will plan again for GMS Sunday in 2022!

Hallelujah! We were back together on October 24th to welcome our Interim Pastor, Rev. Jeff Binder! It was a joyous morning, and we had outstanding in-person attendance that Sunday and the following Sundays leading up to Christmas Eve. Attendance ranged from 80-100+. At-home viewing ranged from 60-161 views, as noted by YouTube.

As in the past, Old Stone was decorated beautifully inside and out for the Christmas season. We appreciate the time and care given by Joan Montgomery, Carol Crane, Tim Holbrook, Mike Leland and Jim Seeley for setting up the delicate manger scene, Christmas trees, garland and wreathes. The Kestersons again provided the fun wood ornaments for the outdoor prayer tree and Brenda and Larry Jones filled the education building urns with magnolia leaves. Thank you for making the Christmas season extra special for us all.

Christmas Eve! We were fortunate to be able to worship together in person and indoors after missing 2020's outdoor service due to inclement weather. We had a lovely

candlelight service with over 140 in attendance! We needed 6 ushers! Can you believe it? Thank you! Norm Ahern, Michael Meadows, Carol and Wilson Bland, Carol Crane, and Lawson Hamilton. - Men's' Breakfast resumed in June and continues to be held the second Wednesday of the month at 8:00 at Shoney's in Lewisburg.
- o Immediately following Sunday church services, a Fellowship table with refreshments & drinks is set up outside to allow for social distancing.
- o In August at Summer's end, we held an outdoor ice cream social.
- "Souper Soups" initiative was started, which supplies the church kitchen freezer with a stock of homemade soups. The idea behind this came from sharing food with those who might be ill or need a quick meal to share. Those inclined to share a favorite or well-loved recipe, package soup in freezable manner, mark contents and date, and bring to the freezer.
- In November, our members contributed fresh, locally grown potatoes to the Food Locker. It was enough to feed about 500 people!
- Also, women of the church joined in to bake individually packaged cookies for those coming Old Stone to pick up food.
- We organized an old-fashioned "Pounding" for Rev Jeff Binder so our congregation could to welcome our new interim pastor and help fill his pantry!
- Fellowship Committee was asked to help women of the church get ready for the Christmas season. We joined forces with the youth group and had a "Fluffing of the Greens" in preparation for the upcoming Sanctuary decoration.

- o In keeping with Covid guidelines, our after-church dinners have not resumed but more activities are coming in 2022.
- o In early January, a small group of like-minded people began our "Walk & Talk" group to share in exercise. Also, a group of ladies attended a "Rip & Stitch" group to work on their own handwork projects and socialize.
- o Fellowship Dinners for small groups of 6-8 people will launch later in February and in March we plan to start a cards/bridge group.

Committees

Community Action (Lou Ella Lewis, Mary Scarborough, Linda Hayes, and JoAnn Pearis) This committee is responsible for promoting the Presbyterian Women's Thank Offering in November and the Birthday Offering. They did an outstanding job this year at remembering the shut-ins of Old Stone with cards and bud vases at Christmas.

Spiritual Enrichment (Amy Brown) In addition to Linda Hayes providing a devotional message at our meetings, this committee supported a card ministry for our church members that are sick, lonely, and have lost loved ones.

Together in Service (Pam Lewis and Becky Kelso) This committee selects a local mission to support for the year. No program was selected for this year.

Women's Retreat (Amy Brown, Susan Graham, and Amy Kesterson) No retreat was held this year.

Projects

Americana (Lynn Weikle and Brenda Jones) - Our thrift store accepts clothing and household donations from the community and sorts/resells them to the community with 100% of the proceeds going to local organizations that assist those in need. We were able to open again in spring, after being closed for January and February due to Covid concerns. Americana Yard Sales were successfully held in April and October. Our new door was installed and window boxes added to the exterior windows.

Care and Gwen's Meals (Betty Dempsey and Arlen Myers) - This program provides bereavement meals for funerals or memorial services and provides meals quarterly for The Shepherd Center to be delivered through their Faith in Action Program.

Flowers (Betty Dempsey and Pam Lewis) - Provide and care for flowers in sanctuary.

McCormick House (Molly Hileman and Dawn Huffman) - We have purchased art supplies and treats bi-monthly for the girls. We also provided funds to purchase mulch and flowers for the girls to plant at Davis Stuart. We also provided Christmas gifts for each of these young ladies. Despite our need to stay safe and not meet in person, we have continued to support the McCormick House.

Scholarships (Betty Dempsey) - Providing local scholarships to the New River Technical College and Old Stone Preschool. Our plan is to sponsor one student for the first semester of 2022 and possibly a second student for the second semester. Our funding will be determined after we investigate the "Free Tuition" policy at New River.

STAIR Tutoring (Debbie Taylor) - This project provides a tutor with second grade students that are struggling with reading during the school year. The program was approved by the school district, with an open house held in December. Tutoring will resume in January 2022, in a new location on the 3rd floor.

Women's Fellowship - The Women's Fellowship members sent Easter and Christmas greetings to all members of our congregation. The ladies also provided "goodies" for all staff at Lewisburg Elementary School in appreciation of their work with students and families. Committee members submitted articles to the church newsletter highlighting our committee's work in hopes of encouraging new participation from members. We prepared a "welcome basket" for our interim minister, Jeff Binder. Donations from our Women's Fellowship group made it possible to provide gift cards at Christmas to the girls at McCormick House.
