STATED SESSION MEETING OLD STONE PRESBYTERIAN CHURCH WEDNESDAY, DECEMBER 21, 2022 HYBRID MEETING

The Session of the Old Stone Presbyterian Church met for their Stated Session meeting on Wednesday, December 21, 2022. The meeting was called to order at 6:00 p.m. by the Moderator, Rev. Jeff Binder. Opening devotions and prayer were presented by Rev. Binder.

Attendance was taken by the clerk and it was declared that a quorum was in attendance.

PRESENT: Moderator/Interim Pastor, Rev. Jeff Binder; Clerk, Nancy Smallenberger; Educator/Program Coordinator, Amy Kesterson: Ruling Elders: Stuart Brown, Jim Coleman, Townley Hamilton, Sara Irons, Scott McClelland and Jennifer Runyon; and guests: newly elected Elders: Renee Ahern, Ann Walker and Gary Williams and Trustee, John Wilson.

EXCUSED: Ruling Elders: Tag Galyean, Megan Kirkham, Karen Leland, Joan Montgomery and Jim Rowe; and newly elected Elder, Amy Meadows.

A motion was made and seconded to approve the docket as presented, with the exception of moving the presentation by John Wilson, on behalf of the Trustees, to this point in the meeting. The motion was APPROVED. The presentation pertained to the church's insurance coverage. The current policy is due for renewal on December 31, 2022. The Trustees recently met to review information presented by a new carrier, with the possibility of changing agencies. As of this time, the Trustees have decided to stay with, and pay the current premium, the current carrier, but will be meeting again to review the coverage provided by the new carrier.

Two sets of minutes were presented for approval:

- Stated Session meeting held on Wednesday, November 16 APPROVED as presented and amended
- Congregational meeting held on Sunday, November 27 APPROVED as presented.

INTRODUCTION/EXAMINATION OF ELECTED RULING ELDERS:

Rev. Binder asked the three newly elected Elders in attendance to give an overview of their faith story and their journey at Old Stone. Following a time of discussion, a motion was made, seconded and APPROVED to sustain the examination and APPROVE Renee, Ann and Gary to serve as Elders; and Amy Meadows was APPROVED in abstention, being as she has previously served a number of terms.

The Ordination and Installation Service will be held, as a part of the worship service, on Sunday, January 1, 2023.

Rev. Binder thanked members of the Class of 2022 for their service: Tag Galyean, Karen Leland and Scott McClelland. It was stated that we give thanks for Chuck Lewis, who was also a member of the Class of 2022.

COMMITTEE REPORTS –

BUILDING USE TASK FORCE – Rev. Binder gave an update on the recent meeting of the group when they met to review and revise/update the Building Use Policy. The group is recommending to pause all long-term building use applications (new inquiries) until a new policy is approved. A motion was made, seconded and APPROVED to accept the recommendation.

SAFETY TEAM – Minutes of the teams recent meeting were included in the packet for Session's review. The group will be meeting again in January.

STEWARDSHIP and FINANCE – Scott McClelland

- Month in Review McClelland stated that the reports he had sent to Session were through December 18th, which showed income had exceeded the budget and expenses were below budget. The committee will be having a Year End Financial Review done after the year ends.
- Stewardship Updates Presently, 70 pledges have been received for 2023, compared to 78 which were received for 2022. A letter is being drafted to be sent to individuals who have not pledged as of now.
- 2023 Budget requests The committee is waiting for all of the pledges to come in before
 preparing the operating budget for 2023. Committee budget requests should have been
 submitted to the committee but if any moderators have questions, contact McClelland or
 Jennifer Runyon. The church has received information from the Presbytery regarding our
 contributions to the Shared Mission contribution and the Per Capita contribution. The
 committee hopes to have the budget completed and ready for approval in January or
 February.

Session will be electing a new church treasurer at the January Stated meeting. Rev. Binder, on behalf of the church, thanked Scott for his efforts this year.

PASTOR'S REPORT – Rev. Binder

- Congregational Care Updates Patty Plumley Richard Franke Norman Ahern's father Lynn Weikle and Family Cam Harkness
- Church Incorporation Updates The amendment for this did not pass during the recent election. Churches are being told by the Presbytery and the state not to file applications now.
- Pastor Jeff reported that he will be on vacation December 25-31. Amy Kesterson will be leading worship on Sunday, December 25. He will also be out of town, attending the DMin class January 7-14. Becky Williams will be filling the pulpit on Sunday, January 8.
- Committees are encouraged to continue meeting and to start identifying moderators for 2023.
- It was reported that the PNC continues to meet and interview candidates.
