STATED SESSION MEETING OLD STONE PRESBYTERIAN CHURCH WEDNESDAY, JULY 27, 2022 HYBRID MEETING

The Session of the Old Stone Presbyterian Church met for their Stated Session meeting on Wednesday, July 27, 2022. The meeting was called to order at 6:00 p.m. by the Moderator/Interim Pastor, Rev. Jeff Binder. Elder, Karen Leland offered devotions and opening prayer.

PRESENT: Moderator, Rev. Jeff Binder; Clerk of Session, Nancy Smallenberger; Educator/Program Coordinator, Amy Kesterson; Ruling Elders: Jennifer Runyon, Townley Hamilton, Stuart Brown, Karen Leland, Sara Irons and Jim Coleman; and guests: Roger Wolfe, Rev. Cameron Harkness and Suzanne Snyder.

EXCUSED/ABSENT: Ruling Elders: Tag Galyean, Scott McClelland, Megan Kirkham, Joan Montgomery and Jim Rowe.

Attendance was taken and it was declared that a quorum was in attendance.

Rev. Binder introduced guest, Roger Wolfe and stated that Mr. Wolfe was wishing to transfer his membership to Old Stone Presbyterian Church. All those in attendance introduced themselves and Mr. Wolfe gave a brief background intro of his church experiences. A motion was made, seconded and APPROVED to receive Roger Wolfe into the membership of OSPC.

Rev. Binder then welcomed Cam Harkness and Suzanne Snyder who were present to give an update on the Bereavement Group that is meeting at the church. The group is led by Harkness and Rev. Ike Hughes and it was reported that twelve (12) individuals have participated. Harkness stated that he and Rev. Hughes are willing to lead at least one more session (six weeks) and they feel that it is a program that needs to be built upon.

APPROVAL OF MINUTES – Two sets of minutes were included in the packet for approval, including:

A motion was made and APPROVED to accept the minutes as presented.

FELLOWSHIP - Karen Leland
