- A Ruling Elder Commissioner is needed for the February meeting of the Presbytery of WV. The meeting will be held via ZOOM on Saturday, February 17, 2024. A motion was made, seconded and APPROVED for Ann Walker to serve as Commissioner.
- Joys and Concerns were covered.

There being no other business that required Session action, the meeting was adjourned and closed with prayer by Pastor Julie.

## **Pebbles of History About Old Stone:**

Congregation organized by "Old Hanover" Presbytery, 1788. Present building erected, 1796. Private school opened by Rev. John McElhenny, D.D., 1808. Lewisburg Academy, to which Greenbrier College and Greenbrier Military School trace their beginning, opened, 1812. Greenbrier Presbytery formed in this church, 1888. Greenbrier Presbytery met in this church, 1840, 1842, 1845, 1847, 1850, 1855, 1864, 1871, 1878, 1883, 1887, 1889, 1899, 1905, 1913, 1928. Synod of Virginia met in this church, 1843, 1857, 1896. "Semi-Centenary Service", marking the fiftieth year of the pastorate of Rev. John McElhenny, D.D., 1858. Dr. McElhenny served this church as pastor for sixty-two years. "One of the first, if not the very first, Sabbath-schools organized in Virginia was in Lewisburg" - Dr. John



McElhenny. Centennial of the organization of the churches at Lewisburg, Union, and Spring Creek observed in joint celebration in the church, 1883. Semi-Centennial of the formation of Greenbrier Presbytery celebrated in this church, 1889. General Assembly met in this church, 1910. Synod of West Virginia formed in this church, 1915. Synod of West Virginia met in this church, 1921, 1928. Seventy-fifth Anniversary of the formation of Greenbrier Presbytery, and One Hundredth Anniversary of the opening of Lewisburg Academy, celebrated in this church, 1913. One Hundred and Twenty-fifth Anniversary of the building of Old Stone Church celebrated, 1921. For a number of years after the organization of the churches at Lewisburg, Union, and Spring Creek there was at no time more than one Presbyterian minister located in this region, and "there was no Presbyterian minister nearer on the east than Lexington, none on the west this side of the Ohio River, none north or south for a distance of at least one hundred miles". Many churches in southern West Virginia and the border counties of Virginia trace their origin to the labors of those pioneer preachers who ministered here.

## Scam Emails/Phone Calls Reminder:

This is a reminder to be diligent and watch out for scammers pretending to be staff of Old Stone. We've already had at least six reported instances this year of a scammer sending fake text messages to our church members pretending to be Rev. Julie. We ask that you reach out to us if you receive any texts, emails, or phone calls pretending to be a staff member so that we can notify church members when this is happening.

If you receive an email, text, or phone call and you aren't sure if it is legitimately from a staff member, please call the church office at (304) 645-2676 to find out. Do NOT reply to the person's text, email, or phone call. We want everyone to be safe and not fall victim to these types of scams.

Just as a reminder, we will NEVER reach out to you asking you to purchase gift cards, request any type of monetary exchange, or request personal information, so you can be sure it is a scam if you are asked for any of these things.

While there is no way for us to prevent this from happening 100%, we are taking additional steps to try to reduce the likelihood of this happening in the future.

In the meantime, Rev. Julie has recommended that you report and then block the phone number that sent you the scam text. You can report the text by forwarding the message to 7726. After you block the number, you shouldn't receive any more scam texts from that phone number.
